Integrity Commission Submits Investigation Report, Ruling and Special Report to Parliament for Tabling

September 5, 2024 – In keeping with its commitment previously made to the public, the Integrity Commission wishes to advise that it has, today, submitted to Parliament, for tabling, a Report of Investigation, and an Associated Indicative Ruling and Full Ruling of its Director of Corruption Prosecution.

A Special Report under Section 36(3) of the Integrity Commission Act, that is associated with the Investigation Report, has also been submitted to the Parliament for tabling.

The foregoing documentation was formally received and signed for at the Parliament at 11:42am today.

Hard copies of the Investigation Report were submitted in separate envelopes, under cover of identical letters, addressed to the following officials:

- (1) The Most Hon. Juliet Holness, MP, Speaker of the House of Representatives
- (2) The Hon. Heroy Clarke, MP, JP, Deputy Speaker of the House of Representatives
- (3) Senator the Hon. Tom Tavares-Finson, OJ, CD, KC, JP, President of the Senate
- (4) Ms. Colleen Lowe, Clerk to the Houses of Parliament

The associated Indicative Ruling, which is embodied in a second and separate letter, together with the Full Ruling of the Director of Corruption Prosecution in the matter, as well as the Section 36(3) Special Report, were also similarly submitted. A USB Flash Drive, containing electronic PDF copies of all documentation submitted, was also conveyed for the attention of the Clerk to the Houses.

Section 36(3) of the Integrity Commission Act provides that “the Commission may, at any time, submit a report relating to any particular matter which, in the opinion of the Commission, requires the special attention of the Parliament.”

The Integrity Commission anticipates that its Investigation Report, which was submitted pursuant to and in conformance with Section 54 of the Integrity Commission Act, together with the referenced Indicative Ruling, Full Ruling and Section 36(3) Special Report, will be tabled in the Parliament as soon as possible.

Section 54(4) of the Integrity Commission Act provides that “where the Report (from the Director of Investigation) to the Commission has a recommendation under subsection (3), **the Commission shall submit it to Parliament for tabling ...**”
