The Integrity Commission's Appointment of a Director of Corruption Prosecution

Kingston; December 3, 2019- The Integrity Commission, is pleased to announce the appointment of Ms. Keisha Prince, as the Director of Corruption Prosecution on secondment from the Office of the Director of Public Prosecutions. Ms. Keisha Prince was granted an Instrument of Appointment on December 2, 2019, by His Excellency the Most Honourable, Sir Patrick Linton Allen, ON, GCMG, CD, for a period of six (6) months, with immediate effect.

The secondment of Ms. Prince will support the Commission's efforts in executing the mandate of the Corruption Prosecution Division, in keeping with Section 34 of the Integrity Commission Act, and will enable the full discharge of the functions of the Division as the Commission completes its recruitment exercise.

Ms. Prince is the holder of Bachelor of Arts Degree in Literatures in English from the University of the West Indies, Mona, a Bachelor of Laws Degree from the University of the West Indies, Cave Hill and a Certificate of Legal Education from the Norman Manley Law School. She was called to the Bar in November 2006.

Ms. Prince has been employed to the Office of the Director of Public Prosecutions for the past eleven (11) years, with her latest appointment being to the post of Deputy Director of Public Prosecutions. During her tenure at the Office of the Director of Public Prosecutions, Ms. Prince headed the Units for Corruption Prevention and Coroner's matters.

As the Commission continues its transition and strives to complete its recruitment of permanent Directors, Ms. Prince will join the team of Directors namely; Colonel Daniel Pryce, Interim Executive Director, Ms. Joy Powell, Acting Director of Information and Complaints; and Mr. David Grey, Acting Director of Investigation.

The Integrity Commission wholeheartedly welcomes Ms. Keisha Prince and reaffirms its commitment and dedication to the people of Jamaica and to the core mandates of this institution.
